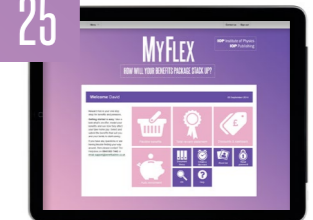

Enjoy preferential rates thanks to specially negotiated corporate discounts and group policies. You won't find these prices elsewhere.

### 2. Spread costs

Take advantage of annual rates, which are taken direct from your pay over 12 months. Great prices without the big, one-off expense.

### 3. Save tax and NI

Benefits paid for through Salary Sacrifice enable you to make tax and/or National Insurance savings. The cost is simply taken from your gross pay, rather than your net pay.

### 4. Deals on your shopping

Save money on everything from food to fashion with a range of discounts, shopping cards and cashback deals available through your discounts and learning portal.

## Did you know you can save money on a brand-new bike?

Assuming you're a basic rate taxpayer, let's see how much you could save on a bike worth £2,000 with Cycle to Work...

Tax Savings (20%)	£400
National Insurance Savings (8%)	£160
Corporate discount (4%)	£80

**That means a £2,000 bike could cost you just £1,360!**

# LIFE EVENTS

What happens if things change?

We know life doesn't stand still. So why should your benefits be any different? If you experience a change in circumstances, you can make changes to annual benefits (normally only available during annual enrolment), subject to HMRC and provider restrictions. We call this a life event.

If your event is related to your work life, such as a substantial change in salary or working hours, this will be activated for you.

If your event is related to your personal life, such as a change in marital status, moving house or becoming a parent, you can submit a life event request through MyFlex, under 'Your benefits'.

We will notify you when your life event window is open, and you can amend selected benefits to suit your changed circumstances.

## How do I review my current benefits?
